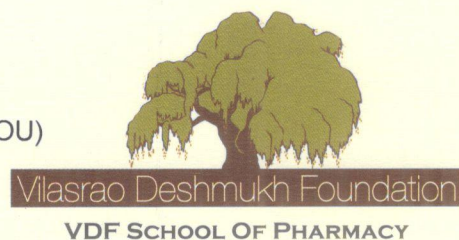


MEMORANDUM OF UNDERSTANDING (MOU)

1) Objectives

2) Technical Areas of Collaboration

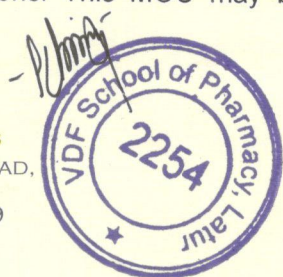

4) Terms and Conditions

Both institutes agree to help the students for their study work as per the terms and conditions of institutions. This MOU may be amended, renewed and terminated by mutual written

agreement of the institutions at any time. Either institute shall have the right to terminate this MOU upon 60 days prior written notice to the other institute.

5) Confidentiality

Institutes agree to hold in confidence all information data designed by the institutes as being confidential which is obtained from either institute or created during the performance and will not disclose the same to any third party without written consent of the other institute.

6) Duration

This MOU, unless extend by mutual consent of the institutes shall expire in 10 years after the effective date specified in the opening paragraph.

7) Coordinators


Both institutes will designate persons who will have responsibility for co-ordination and implementation of this agreement.
