

Memorandum of Understanding (MoU)

Between

Vilasrao Deshmukh Foundation, Group of Institutions, VDF School Pharmacy, Latur And

Gayatri Super Speciality Hospital, Latur

This Memorandum of Understanding (MoU) is made and entered into on this 01/07/2024, by and between: VDF School of Pharmacy, Latur, located at New MIDC, Airport road Latur hereinafter referred to as "College" AND Gayatri Super Speciality Hospital Latur, hereinafter referred to as "Super Speciality Hospital".

1. Purpose:

- Provide pharmacy students with hands-on clinical training in a hospital setting.
- Exposure to real-time patient care and drug therapy monitoring.
- Joint research in pharmacology, clinical trials, pharmaceutics, pharmacovigilance, etc.
- Sharing of data, lab facilities, and expertise.
- Hospital professionals may offer guest lectures or workshops.
- College faculty may assist in drug information services or patient education.
- Organize continuing medical/pharmacy education (CME/CPE) programs.
- Joint outreach programs, health camps, and awareness campaigns.

2. Objectives:

• To establish a framework for collaboration in clinical training, research, faculty exchange, and public health initiatives.

3. Areas of Collaboration:

- Clinical exposure and training for B.Pharm / M.Pharm students.
- Joint research and academic projects.
- Use of hospital facilities for training and internships.
- Participation in workshops, seminars, and conferences.
- Pharmacovigilance and drug utilization studies.

4. Roles & Responsibilities:

Pharmacy College:

Ensure that students are prepared with foundational knowledge

Coordinate schedules and supervision.

Hospital:

- Permit access to hospital wards, labs, and pharmacies.
- Assign mentors/preceptors.
- Support data collection and patient interaction under supervision.

5. Duration:

This MoU is valid for a period of Ten years from the date of signing, with the possibility of renewal upon mutual agreement.

6. Confidentiality:

Both parties agree to maintain confidentiality of patient data and institutional information.

7. Dispute Resolution:

Any disputes arising shall be resolved amicably through mutual consultation.

8. Termination Clause:

Either party can terminate this MoU with a 30-day written notice.
