

College of Engineering, Terna Public Charitable Trust's College of Engineering, Department of Pharmacy, Osmanabad the First Party represented herein by its Principal, TPCT's College of Engineering, Osmanabad And Vilasrao Deshmukh Foundation, VDF School of Pharmacy, Latur 413531 the Second party, and represented herein by its Principal, VDF School of Pharmacy, Latur

WHEREAS:

- A) First Party is a Higher Educational Institution named: College of Engineering, TPCT's College of Engineering, Osmanabad. 413501
- B) The second party is also a Higher Educational Institution named: Vilasrao Deshmukh Foundation, VDF School of Pharmacy, Latur. 413531
- C) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- D) The Parties intent to cooperate and focus their efforts on cooperation within area of research, resource utilization, healthcare improvement, formulation development, and Expert Lecture.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1

CO-OPERATION

The purpose of this MoU is to establish an academic collaborative relationship between the Department of Pharmacy, Terna Public Charitable Trust's College of Engineering, Osmanabad and the Vilasrao Deshmukh Foundation, VDF School of Pharmacy, Latur for the mutual benefit of academic advancement, research and development, professional training, and skill development of pharmacy students.

- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities.

1.3 The parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

CLAUSE 2

SCOPE OF THE MoU

- 2.1 Both the parties shall support each other in planning, and executing the programme that promote research and development among Pharmacy students
- 2.2 Both the parties shall support each other indifferent case studies in the domain of clinical pharmacy and hospital practice.
- 2.3 Both the higher education academic institutes shall organize technical workshops, expert talks or guest lecturers for B. Pharmacy students in their respective areas of interest.
- 2.4 Both the higher education academic institutes shall encourage joint research activities and projects by faculty members of both the involved parties
- 2.5 There is no financial commitment from both the parties. If there is any financial consideration, it will be dealt separately.
- 2.6 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required.

CLAUSE 3

VALIDITY

3.1 This MoU shall remain valid for a period of **ten** (10) **years** from the date of signing and may be renewed upon mutual agreement.

CLAUSE 4

RELATIONSHIP BETWEEN THE PARTIES

4.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership.

Confidentiality:

Both parties agree to maintain the confidentiality of any proprietary or sensitive information exchanged under this MoU.

Termination:

This MoU may be terminated by either party with a written notice of 30 days, citing reasons thereof.
