This Memorandum of Understanding (MoU) is made on this **10/12/2023** between:

1. Vilasrao Deshmukh Foundation, School of Pharmacy, Latur, Maharashtra, hereinafter referred to as "VDF School of Pharmacy" (First Party).
2. Primary Health Center (PHC), Chikhurda, Latur, Maharashtra, hereinafter referred to as "PHC Chikhurda" (Second Party).

Purpose:

The purpose of this MoU is to establish a collaborative partnership between VDF School of Pharmacy and PHC Chikhurda for:

1. Training and orientation of pharmacy students in community and hospital pharmacy practices.
2. Joint health awareness and outreach programs for rural populations.
3. Academic, research and community-based projects related to public health and pharmacy services.
4. Strengthening the delivery of primary healthcare services through student support under supervision.

Scope of Collaboration:

Both parties agree to collaborate in the following areas:

1. Student Training & Internship:

VDF School of Pharmacy students may undertake field visits, and community pharmacy activities at PHC Chikhurda under supervision.

2. Health Programs & Camps:

Jointly organize health awareness camps, immunization drives, and disease prevention programs.

3. Research & Projects:

Conduct collaborative research on rural health issues and pharmacy services.

4. Resource Sharing:

Sharing expertise, facilities, and manpower as mutually agreed.

Roles and Responsibilities VDF School of Pharmacy, Latur shall:

- A. Provide details of students and faculty participating in PHC activities.
- B. Ensure students adhere to the rules and regulations of PHC during their training.
- C. Provide support in organizing health awareness programs.

PHC, Chikhurda shall:

- A. Facilitate field training and exposure for students.
- B. Provide guidance and supervision to students during their visits.
- C. Allow the use of PHC premises for mutually agreed activities.

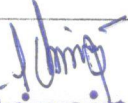
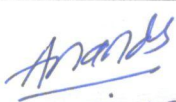
Validity:
